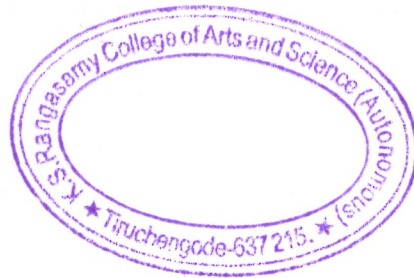

Detailed budget proposal for the Controller of Examinations has been submitted for review.

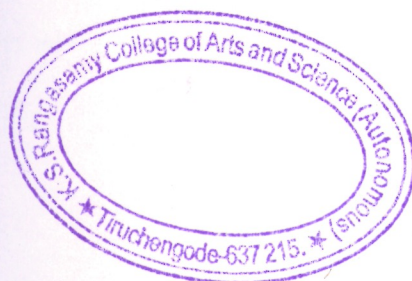
It was seconded by Dr. K.M. Prabusankarlal and they were **approved**.
