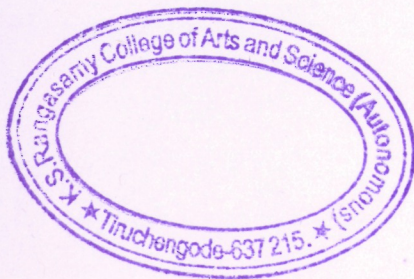

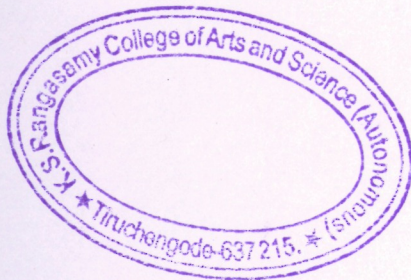
It was seconded by Dr. K.M. Prabusankarlal and they were **approved**.

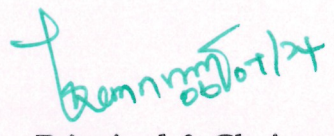
ITEM V : Any Other

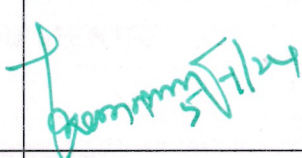
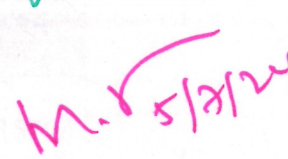
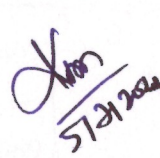
