The Principal & Chairman of the finance committee submitted the detailed audited annual statements.

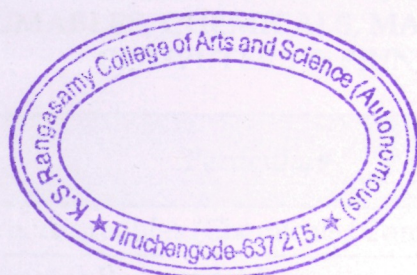
The resolutions were seconded by Dr. M. Venkatesh and they were **approved**.
