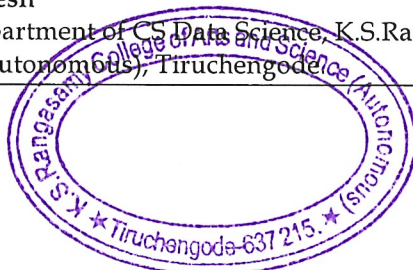

Item 9: Any other

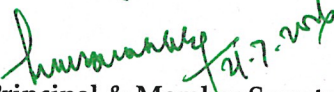
The members of the Governing Council placed on record their appreciation for the commendable efforts of the Management, Principal, faculty members, and staff of K.S. Rangasamy College of Arts and Science (Autonomous) in effectively implementing the recommendations and decisions of the **26th Governing Council Meeting**. The Council acknowledged that the initiatives undertaken had significantly contributed to the enhancement of academic excellence, research, student development, and institutional growth.

The Governing Council further made the following recommendations and suggestions during the meeting:

1. **Seed Money Scheme:** The Hon'ble Members appreciated the Management for implementing the Seed Money Scheme to promote research and innovation. The Council recommended that the evaluation of seed money proposals be carried out by a committee comprising internal and external subject experts. The proposals may be evaluated based on the recommendations of the expert committee. It was further suggested that the proposal submission and evaluation schedule be announced well in advance, preferably at the beginning of every academic year, to facilitate effective planning and implementation.
2. **Promotion of Research and Development:** The Hon'ble Members advised the institution to encourage faculty members to submit a greater number of research proposals to various funding agencies. At the same time, the institution was advised to provide necessary support and reasonable flexibility to researchers to undertake research and development activities effectively.
3. **Village Adoption Scheme:** The Council recommended that the institution give greater attention to the effective implementation of the Village Adoption Scheme. The activities undertaken under the scheme should be systematically monitored and the outcomes should be assessed annually or on a need-based basis. The Council further advised that all activities and outcomes of the scheme be properly documented and maintained through appropriate statistical records for effective evaluation and future planning.
4. **Internship Duration:** The Hon'ble Members advised the institution to ensure that the duration and implementation of internships for final-year students strictly adhere to the guidelines and norms prescribed by the UGC and the affiliating University.
5. **Curriculum Revision:** The Hon'ble Members suggested that approximately 5-10% of the course content may be updated periodically to reflect recent developments in the respective disciplines. Further, the Council recommended that, wherever necessary and permissible, approximately 25-30% of the curriculum may be revised during the introduction of each new academic regulation, in accordance with the applicable norms.
6. **External Valuation of End-Semester Examinations:** The Hon'ble Members suggested that the institution consider implementing 100% external valuation for the theory papers of the End-Semester Examinations to further strengthen the transparency, objectivity, and credibility of the evaluation process.
7. **Supplementary Examination:** The University Nominee suggested that the institution may consider providing an opportunity for students to appear for a supplementary examination in theory courses, subject to the applicable regulations, provided that the students have a maximum of two arrears in the entire programme, thereby facilitating the timely completion of their academic programme.
8. **Scholarship Performance and Renewal:** The Hon'ble Members recommended that the award and renewal of institution scholarships be linked to the academic performance and overall progress of the students, wherever applicable. The performance of scholarship recipients should be analysed and reviewed annually, and the continuation or renewal of the scholarship may be considered based on the students' performance and eligibility criteria.

9. **Financial Support for Faculty Research Presentations:** The Council suggested that the institution may consider providing financial support of up to **50% of the registration fee** to faculty members who present their research work at reputed academic and research organisations, subject to the availability of funds and the prevailing institutional norms.
10. **Soft Skills Development:** The Hon'ble Members advised the institution to give greater emphasis to soft skills development among students. Structured training programmes focusing on communication skills, interpersonal skills, leadership, teamwork, employability skills, and professional development may be strengthened to enhance students' overall personality and career readiness.

To conclude the meeting, Mr. T. Rajendrakumar, IQAC Coordinator, proposed a vote of thanks and expressed gratitude to the Governing Council Members for their valuable insights and recommendations, which contribute to the pursuit of academic excellence.
